

INDUSTRY LEADERSHIP


Soy Canada provides leadership and a voice for Canadian soybeans when challenges or opportunities emerge that require value chain collaboration and coordination.

Leadership in action

Based at GrainsHQ in Ottawa with five other national grain organizations, Soy Canada keeps its finger on the pulse of federal policy affecting the soybean industry and advocates on priorities needed by the value chain. In the last year, Soy Canada focused on improved access to international markets, enabling a competitive rail and container supply chain, and seeking regulatory excellence such as the full adoption of electronic export documentation. As part of our advocacy, our board hosted a 10th anniversary breakfast for MPs and Senators in October 2024. While celebrating the anniversary, we shared how federal policies were hindering our success and advocated for solutions.



Sustainable Canadian Soy continues to expand

Food-Grade Variety Finder helps customers get what they need

The Food-Grade Variety Finder offers essential information on the quality characteristics of Canadian food-grade soybeans, allowing customers to search for varieties tailored to their specific end-use needs. It's a comprehensive database of food-grade soybean varieties, featuring data from more than 1,600 food-grade soybean variety samples that are tested through the Soy Quality Program.

MARKET ACCESS & TRADE POLICY

Tariff and non-tariff barriers limit access to markets, limiting the value of our exports and creating risk. Soy Canada works to prevent and resolve emerging and ongoing issues by bringing the sector together to be more effective at working with governments and import partners. We provide our members with better knowledge to mitigate trade risk and expand access to new opportunities.

Working for value and stability

Amid global trade disruptions and geopolitical challenges, Soy Canada remained committed to working to maintain existing markets, opening new ones, reducing risks, and enhancing value.

In May 2023, the European Union approved a regulation requiring all soy imported into the EU to come from land that was not deforested. Since then, Soy Canada has taken the lead in bringing the value chain together to help producers, exporters and processors navigate this upcoming market access requirement. Our EU deforestation working group has met regularly to create a space for collaboration, to share information as well as expected impacts and concerns. More than 100 hours of time has been invested collectively by members and impacted stakeholders ahead of implementation in December 2025.


Participation by segment in EU deforestation working group



Indonesia

In December 2024, the Canada-Indonesia Comprehensive Economic Partnership Agreement (CEPA) was signed. Soy Canada provided advice to the Canadian government throughout the negotiations, resulting in an agreement that eliminates tariffs on soy exports and creates new obligations to reduce non-tariff barriers related to seed innovation and crop protection products.

Fresh on the heals of free trade agreement being signed, a Soy Canada delegation visited Indonesia in February 2025 as part of its Indo-Pacific mission. During the visit, we met with Indonesian government representatives to discuss how regulations can enable trade and allow importers to purchase the quality of soy they want.

COORDINATE RESEARCH & INNOVATION

With complex and diverse needs across the country, getting the best results from research and innovation investment requires coordination along the value chain. Soy Canada enables alignment to ensure investments in research and innovation have the greatest impact on growing opportunities and reducing risk.

Driving results: the success of the **Soy Quality Program**

One of the greatest highlights of the past year was the transition and renewal of the Soy Quality Program. It provides independent, third-party compositional and functional analysis of Canadian food-grade varieties so we can be the origin of choice for our customers.

A legacy of quality

After more than 30 years at Agriculture and Agri-Food Canada's Harrow facility, the government announced its cancellation in November 2023. The industry came together to identify new funding, a modernized mandate and a new delivery partner in the Canadian Grain Commission. Today, our dedication to excellence in soy quality testing remains strong.
